## REVISION OF FEES FOR ARMS, EXPLOSIVE AND EXPLOSIVE PRECURSOR LICENCES AND REVISION OF LICENSING REQUIREMENTS FOR EXPLOSIVE PRECURSOR LICENCES

Please note that as part of the Police's fees review, we will be implementing the following changes to the fees and licence requirements pertaining to the licensing of Arms, Explosives and Explosive Precursors. The revised licence fees will take effect from 13 September 2010. Licences issued and payment made on or after 13 September 2010 will be subjected to the revised fees. The revised fees are shown in Table 1, Table 2 and Table 3.

- We would like to highlight that the main change in the licensing requirements for explosive precursor licences is that the storage licence will no longer be tagged with other licences. Generally, a separate storage licence is required if you are storing explosive precursors within your company premises. Further details are shown in Table 4.
- 3 Current explosive precursor licensees who will be affected by these changes are to take up the additional licence only <u>upon renewal of their existing licences</u>.
